# **Terms of Use Agreement**

Welcome to the website and online service of Healthy Haiku Productions. This page explains the terms by which you may use our online and/or mobile services, web sites, and software provided on or in connection with the service (collectively the "Service"). By accessing or using the Service, you signify that you have read, understood, and agree to be bound by this Terms of Use Agreement ("Agreement") and to the collection and use of your information as set forth in the Company Privacy Policy, whether or not you are a registered user of our Service.

We reserve the right to amend this Agreement at any time by notifying you as provided in this Agreement, provided that no notice shall be required for non-substantive changes to the Agreement (including the policies and procedures referenced herein). If we substantively amend this Agreement, we will give you at least seven (7) days notice before the changes take effect, during which period of time you may reject the changes by terminating your account and immediately discontinuing use of the Service. Your continued use of the Service after any such change constitutes your acceptance of the new Terms of Use. If you do not agree to any of these terms or any future Terms of Use, do not use or access (or continue to access) the Service. This Agreement applies to all visitors, users, and others who access the Service.

If you accept or agree to this Agreement on behalf of a company or other legal entity, you represent and warrant that you have the authority to bind that company or other legal entity to this Agreement and, in such event, "you" and "your" will refer and apply to that company or other legal entity.

# 1. Healthy Haiku Productions, LLC Service

This web site provides an online platform that connects Healthy Haiku Productions ("Provider") services and activities with guests, Prospective Clients and Prospective Affiliates seeking to learn about, utilize or participate in such services and activities as Clients or ("Affiliates"). Provider can offer a wide variety of services and activities to Clients or Affiliates on the Service, including classes, experiences and gatherings, and tasks, and other services and activities ("Services").

# 2. Eligibility to Join as an Affiliate

Your use (with the exception of guests and Clients) of the Web Site constitutes a binding contract with Healthy Haiku Productions, LLC, and you as an Affiliate who agrees to be in compliance with this Agreement and all applicable local, state, national, and international laws, rules and regulations. Any use or access to the Web Site by anyone under 13 is strictly prohibited and in violation of this Agreement. The Service is not available to any Users previously removed from the Service by Healthy Haiku Productions, LLC.

#### 3. Service Rules

Affiliates are only retained to make referrals of new Clients and Prospective Affiliates. All financial transactions are strictly between the Clients (and Prospective Affiliates) and Healthy Haiku Productions. Affiliates are responsible solely for making Referrals and will not be involved in collecting fees. All successful Referrals will result in Commissions for the Referring Affiliate. Success is defined as

transactions resulting in a contract with the Client of new Affiliate. Commission rates are listed in the Back Office of the Web Site.

# In connection with your use of our Service, you may not and you agree that you will not:

In addition, although this Agreement require Affiliates to provide accurate information, we do not attempt to confirm, and do not confirm, any Affiliate's purported identity. You are responsible for determining the identity and suitability of others who you contact via the Web Site. Healthy Haiku Productions, LLC will not be responsible for any damage or harm resulting from your interactions with other Users. By using the Web Site, you agree that any legal remedy or liability that you seek to obtain for actions or omissions of other Users or other third parties will be limited to a claim against the particular Users or other third parties who caused you harm and you agree not to attempt to impose liability on, or seek any legal remedy from Healthy Haiku Productions, LLC with respect to such actions or omissions. Commissions from all transactions will be posted in the Affiliate's Healthy Haiku Productions account, one time weekly after the occurrence of the Contract. Payment shall be remitted via PayPal to Affiliates. Therefore Affiliates must set up a PayPal account.

#### 7. Taxes

IRS regulation, regarding federal tax reporting requirements, stipulates that Healthy Haiku Productions must collect IRS Form W-9 from Affiliates in the United States. You understand and agree that you are solely responsible for determining your applicable tax reporting requirements in consultation with your tax advisors. Healthy Haiku Productions, LLC cannot and does not offer tax-related advice to any Users of the Service.. You are also responsible for paying any governmental taxes imposed on your purchase from or use of the Healthy Haiku Productions Web Site, including, but not limited to, sales, use, or value-added taxes. To the extent Healthy Haiku Productions is obligated to collect such taxes, the applicable tax will be added to your billing account.

# 8. Employment and Withholding

#### 17. Notices

Any notices or other communications permitted or required hereunder, including those regarding modifications to this Agreement, will be in writing and given by Healthy Haiku Productions (i) via email (in each case to the address that you provide) or (ii) by conspicuous posting to the Service. For notices made by e-mail, the date of receipt will be deemed the date on which such notice is transmitted.

# 18. Dispute Resolution

In the unlikely event that Healthy Haiku Productions Customer Service Department is unable to resolve a complaint you may have to your satisfaction (or if Healthy Haiku Productions has not been able to resolve a dispute it has with you after attempting to do so informally), we each agree to resolve any claim, dispute, or controversy (excluding any Healthy Haiku Productions for injunctive or other equitable relief) arising out of or in connection with or relating to this Agreement, or the breach or alleged breach thereof (collectively, "Claims"), by binding arbitration by the American Arbitration Association ("AAA") under the commercial rules then in effect for the AAA, except as provided herein. The award rendered by the arbitrator shall include costs of arbitration, reasonable attorneys' fees and reasonable costs for expert and other witnesses, and any judgment on the award rendered by the arbitrator may be entered in any court of competent jurisdiction. Nothing in this Section shall be deemed as preventing Healthy Haiku Productions from seeking injunctive or other equitable relief from the courts as necessary to protect any of Healthy Haiku Productions proprietary interests. ALL CLAIMS MUST BE BROUGHT IN THE PARTIES' INDIVIDUAL CAPACITY, AND NOT AS A PLAINTIFF OR CLASS MEMBER IN ANY PURPORTED CLASS OR REPRESENTATIVE PROCEEDING. YOU AGREE THAT, BY ENTERING INTO THIS AGREEMENT, YOU AND HEALTHY HAIKU PRODUCTIONS ARE EACH WAIVING THE RIGHT TO A TRIAL BY JURY OR TO PARTICIPATE IN A CLASS ACTION.

# 19. General

The failure of Healthy Haiku Productions to enforce any right or provision of this Agreement will not constitute a waiver of future enforcement of that right or provision. The waiver of any such right or provision will be effective only if in writing and signed by a duly authorized representative of Healthy Haiku Productions. Except as expressly set forth in this Agreement, the exercise by either party of any of its remedies under this Agreement will be without prejudice to its other remedies under this Agreement or otherwise. If for any reason an arbitrator or a court of competent jurisdiction finds any provision of this Agreement invalid or unenforceable, that provision will be enforced to the maximum extent permissible and the other provisions of this Agreement will remain in full force and effect.

# 20. Definitions

Affiliate: Independent Representatives of Healthy Haiku Productions retained to make Referrals of new Clients and Prospective Affiliates.

Client: Schools, churches, mentoring organizations, and individuals that may engage services of Healthy Haiku Productions.

Services: Healthy Haiku Workshops for "Tweens" and Teens; Train the Trainer Programs; Speaking Engagements, and any additional services so defined in the future and added to this agreement.

Referral: Connection made by Affiliate of new Client of Prospective Affiliate to Healthy Haiku Productions for engagement of services.

Transaction Fee: Deposit for Engagement (10% of Engagement Fee). All Transaction fees to be paid directly to Healthy Haiku Productions.

Engagement fee: Fee charged for Services by Healthy Haiku Productions. All Engagement fees to be paid directly to Healthy Haiku Productions.
